SUMMARY OF MEETING: This meeting discussed lead content of books and specific book components. The industry discussed the results of testing for lead; provided overviews of industry materials and practices, including supply chain controls. The industry representatives concluded from their testing and knowledge of industry practices that children's ordinary books will not have lead content that exceeds the limits provided in the Consumer Product Safety Improvement Act, and should not be required to be tested. They mentioned that novelty books, such as books with play value, already undergo testing and that testing will continue.
