STATEMENT OF WORK

**Project:** All terrain vehicles; Project Number 22637

**Purpose/Justification:**

The purpose of this request is to modify the Memorandum of Understanding (MOU) between the U.S. Army Aberdeen Test Center (ATC) and the U.S. Consumer Product Safety Commission (CPSC), which is currently in place to conduct testing of adult model all terrain vehicles (ATVs) and recreational off-highway vehicles (ROVs). **This modification , MOU CPSC-I-07-0003, is to add \$50,000** to continue testing of Recreational Off-highway Vehicles (ROVs) and adult sized ATVs. The testing to be conducted is identical to that which is already described in the MOU and all ROVs and ATVs will be provided by CPSC.

**Objectives**

The tests are intended to document the static and dynamic stability characteristics of ROVs and adult ATVs while providing a baseline against which to compare the stability performance of different brands and models. The specific objectives are to:

- Evaluate the ROVs and ATVs lateral stability characteristics
- Evaluate the ROVs and ATVs steering characteristics
- Determine if there are characteristics of certain models which make them more stable and/or less incident prone than other models

**Description of Services:**

ATC personnel will develop tests set-ups and instrumentation to evaluate the test articles to be provided by the CPSC. Testing and evaluation will be conducted as described in the MOU CPSC-I-07-0003.
